The Monrovia City Corporation (MCC) provides oversight regulation and is responsible for waste management within the municipality.

It promotes the mantra of "Clean, Green and Resilience" city.





OVERVIEW OF SOLID WASTE MANAGEMENT IN MONROVIA

- The overarching solid waste management sets out the vision which reorganizes safe collection, treatment and disposal of solid waste generated by population.
- Promoting sound public health, clean environment and socially satisfactory manner by using most economical and available means.

REASONS FOR CHALLENGES

- Limited government budgetary allocation to the sector
- Public perceptions of waste management
- Inadequate human resource capacity

AWARENESS CAMPAIGN ON SOLID WASTE MANAGEMENT

RESULT OF ACTUAL ACTIVITIES

- Lessons learned from Japan (JICA) have added value and capacity to waste management of the Municipality of Monrovia.
- MCC expanded our engagement with community dwellers and stakeholders on proper waste disposal and corresponding public health consequences, which enables many of them to realize the significance of a clean and safe environment.
- National dialogue on solid waste management has heightened the public perception, which led to a two-day citywide solid waste conference in November 2018.

WAY FORWARD

- MCC should solicit support from the international community through multi/bilateral agreements on investing their knowledge and technical know-how in Monrovia for the sake of an environmentally sound management of waste streams.
- Private sectors should be actively involved in solid waste management and be a collaborative partner of government bodies. This will create more employment opportunities for the growing population.
