

Lake Victoria Water & Sanitation Program

- Beneficiary: 15 towns in 5 countries in Lake Victoria Basin
- Phase I: Waste collection service capacity development and vehicle provision
- Phase II: Construction of solid waste and feacal sludge treatment plant and provision of capacity development on solid waste and feacal sludge management
- Achievement: 1) Improved waste collection services

2) Innovative treatment facility model that combines landfill site and feacal sludge treatment site with bio-digester







UN-Habitat Commitment



Pilot Landfill Site in Kiambu County

- Beneficiary: Kiambu County, Kenya
- Component: Construction of pilot Fukuoka method landfill site that can be constructed with local material at low cost
- Achievement: 1) Engagement and empowerment of waste pickers
 - 2) Use of local material
 - 3) Collaboration with JICA in Training of county officials
- Future plan: Operation start and monitoring and construction of the same landfill site in other African cities





UN-Habitat Commitment



SWM Improvement in Kisii County

- Beneficiary: Kisii County, Kenya
- Component: Rapid Assessment of Current Status of SWM Development of Long Term Strategy for SWM Improvement Pilot
- Achievement: 1) Waste Data collected
 - 2) Long term strategy developed
 - 3) Income enhancement for youth who are engaged in street cleaning
- Future :Upscaling of the pilot to sub-counties and other countiesEstablishment of SWM Unit in county government

UN-Habitat Commitment Rehabilitation of Koshe Dumpsite in Addis

- Beneficiary: Addis Ababa City, Ethiopia
- Component: Rehabilitation of collapsed Koshe Dumpsite in Addis Ababa Onsite capacity development of disposal site operation
- Started in April 2018 Status:

Disposal Improvement in Bahir Dar

- Beneficiary: Bahir Dar City, Ethiopia
- Component: Construction of Fukuoka Method sanitary landfill site On-site capacity building of construction, operation and maintenance of Fukuoka Method sanitary landfill site
- Status: Started in April 2018







- 1. Needs assessment of cities in SWM improvement
- 2. Identification of effective interventions
- 3. Concept note development
- 4. Stakeholders engagement and political support from decision makers
- 5. Support cities to apply for funds





- 1. Readiness of Cities
 - Appropriate local institutional arrangement that can support project implementation
 - Appropriate policy and legislation basis
 - Economic analysis on intervention value for money
- 2. Fit for Funding Requirements
 - Carbon emission reduction
 - Integration with other sectors (e.g. urban planning, transport, energy, etc.)
 - Regional project, rather than one country or cities
