PASSOS DADOS: DATA STEPS

- Submission to the Minister of Justice, Constitutional and Religious Affairs for the recognition of the National Association for Waste Management - ANGER. (Under paragraph 1 of Article 5 of Law 8/91 of 18 July, in conjunction with Article 1 of Decree No. 21/91 of 3 October).
- ANGER recognized as a legal entity, through the order of March 30, 2017

Historical Context (Cont.)



For ANGER, to be efficient, effective, aggregate and provide transversal and multisectoral technical skills in the area of waste management, two **basic principles** have been defined strategically:

 Treat the waste in a general way, transversal or without discrimination of their physical state and origin (Urban, Rural and Industrial)
